MANAGEMENT OF FSC CHAIN OF CUSTODY

BATHSYSTEM SpA has decided to implement and maintain the FSC chain of custody for forest products used in the prefabricated cells it manufactures.

It therefore declares its commitment to complying with the FSC values as defined in document FSC-POL-01-004 - “Policy for the Association of Organizations with FSC” (first approved in July 2009) and declares that it is not directly or indirectly involved in the following activities:

- illegal harvesting or trade in forest products;
- violation of traditions and human rights within the forestry or forest products sector;
- destruction of areas, forests or other types of vegetation considered to be of high conservation value especially as regards social or environmental importance;
- significant conversion of forests to plantations or non-forest use;
- introduction of genetically modified organisms into the environment during forestry activities;
- violation of any principle laid down by the International Labour Organization (ILO) convention defined in the “Declaration on Fundamental Rights and Principles at Work”; in particular, it undertakes to:
 - have due regards to the rights and obligations established by national law;
 - not employ child labour
 - abolish all forms of compulsory forced labour;
 - not discriminate in employment and occupation;
 - respect the freedom of association and the actual right to collective bargaining.

STRATEGY AND IMPROVEMENT

The General Management defines its strategic objectives, which it re-examines periodically to check that they are up to date and effective, for the purposes of:

- continuous improvement,
- reviewing its policy, which represents the reference framework for the quality and environment objectives.
